- Be a high school student who is at least 16 years of age at the time of the election
- Be a United States citizen or lawfully admitted for permanent residence (green card holder)
- Have a grade point average of at least 2.5 on a 4.0 scale
- Have a Pollchief account (if you don't, you can apply at socovotes.com)
- Have applied for the election you wish to work in Pollchief and submitted what days you can work

The polls are open up to 10 days before Election Day, including weekends. Please be available to commit to an entire day of work (8 am - 6 pm on Early Voting Days and 6 am - 9/10 pm on Election Day). **Placement is based on available slots and is not a guaranteed.**

Students will report to their assigned Vote Center at 6 a.m. on Election Day (8 a.m. on early voting days) and stay until the polls are closed and all supplies are packed (approximately 9 –10 p.m. on Election Night and 6 p.m. on early voting days). Students are given lunch and dinner breaks plus short breaks throughout the day as needed. Students will receive a \$160 stipend, \$240 on Election Day, for serving at a Vote Center.

The Registrar of Voters requires parental/guardian and teacher/counselor permission, and does not assume responsibility for the minor, and we ask you to sign below to authorize the minor's participation. By signing this application, you, the parent/guardian and teacher/counselor, affirm that the facts set forth in it are true and complete.
