Dear Voter:

We have determined either that the signature you provided on your Vote by Mail or Provisional ballot envelope does not compare with the signature(s) on file in your voter record or that you did not sign your ballot envelope. To ensure that your Vote by Mail or Provisional ballot will be counted, this Statement must be signed and the signature must compare with the signature(s) in your voter registration record. This form must be received by our office no later than 5pm on Wednesday, June 24, 2026. Failure to complete and return this form on time may cause your ballot not to count. Please note that the signature provided on the completed Statement may be added to your registration record to be used for signature comparison purposes in future elections.

I am a registered voter of Sonoma County, State of California. I declare under penalty of perjury that I received and returned a Vote by Mail or Provisional ballot and that I have not and will not vote more than one ballot in this election. I am a resident of the county in which I have voted, and I am the person whose name appears on the ballot envelope. I understand that if I commit or attempt any fraud in connection with voting, or if I aid or abet fraud or attempt to aid or abet fraud in connection with voting, I may be convicted of a felony punishable by imprisonment for 16 months or two or three years. I understand that my failure to sign this statement means that my Vote by Mail or Provisional ballot will be invalidated.

Your county elections official is required to compare your signature with the signature(s) in your voter registration record, which may include the signature appearing on your driver's license or state identification card.
