#### VI. New Business

A. Tiffany Stinson of Department of Fish & Wildlife regarding Abalone Regulation Enforcement. *First reading*.

**Report**: A request of \$649.92 to purchase a freezer to store evidence confiscated related to illegal take of abalone and other fish and game.

Action: Second reading will occur at February 2013 meeting.

B. Kristen Reeder of Sonoma County Wildlife Rescue regarding Perimeter Fence. *First reading.* 

**Report**: A request of \$4,500 to allow the completion of an 8 foot parameter fence around their education exhibit.

During the discussion concern was expressed regarding the overall monies given to SCWR and the other wildlife rescue groups which were double. It was also stated that SCWR was under the wrong impression as to the amount of monies the Commission has to spend each year.

**Action**: Crystal requested additional information for the second reading: The amount of funds received from the prosecuted case regarding the two Mountain Lion cubs in Napa and the amount of hours work provided by the perpetrators. Second reading will occur at February 2013 meeting.

B. Public.

Kathy Cowan introduced herself and gave a brief explanation of her business.

Capt. Steve Riske, DFG – gave an update on happenings in the area. They are in the beginning stages of meetings with regards to the MPA's (Marine Protection Area) in Northern California. They hope to bring agencies and public together to find better ways to identify these areas. Possibly with signs and brochures, similar to what have set up on Southern California.



Warden James Reed, DFG – reported that the signs about crab sizes are up at Bodega and they look great.
